Sir Knight Smith enjoys an excellent reputation among his peers, having been elected President of the American Society of Legislative Clerks and Secretaries from 2019 through 2021. He is **currently Vice Chair of the Mason's Manual** 

Commission, updating the *Manual of Legislative Procedure for State Legislatures and Other Legislative Bodies* originally published by Paul Mason in 1937.

Sir Knight Smith is an Eagle Scout, having achieved the rank in 1998. Before assuming his legislative responsibilities, he served the Daniel Webster Council as a District Executive. He currently serves as Den Leader **for his son's Cub Scout Pack**. In January 2017, Sir Knight Smith received the Outstanding Eagle Scout Award of the National Eagle Scouts Association at the Daniel Webster **Council's** Annual Eagle Scout Recognition Ceremony, at which Your editor was pleased to be present.
